4. Method of appointment : Direct  
1) Category No. 267/08 Open merit  
2) Category No. 268/08 From Graduate Head Constables, Police Constables and Officers of corresponding rank in Police or Vigilance Department.

5. No. of vacancy : Category I -8 (Eight)  
Category II -anticipated

6. Age limit : Category I - Must have completed 20(Twenty) years and must not have completed 30 (Thirty) years as on 1.1.2008.  
Category II - Must have completed 20 (Twenty) years and must not have completed 35 (Thirty five) years as on 1.1.2008.

(for conditions regarding the other age relaxation please see para (2) of the General Conditions.)

The existing vacancies and the vacancies that may be reported to the Commission in writing during the period of currency of the Ranked List published by the Commission in response to this notification will be apportioned among (1) open market and (2) Graduate Head Constables, Police Constable and officers of the corresponding rank in Police or Vigilance departments in accordance with the order contained in the GO(P) No. 6/84/Home dated 18.1.1994. The relative seniority of the candidate in the above two categories will be deducted as laid down in GO(MS) 217/86 dated 10.10.1980.

**Note:** 1. The list of selected candidates published by the Commission in response to this notification shall cease to be in force after one year from the date of finalisation of the Ranked List or after one month from the date of commencement of training in respect of the last batch of candidates advised from the Ranked List within a period of one year from the date of finalisation of the Ranked List whichever is later. Candidates will be advised from the said list against the vacancies noted above and that may be reported to the Commission in writing during the period of currency of the list in accordance with the orders contained in GO(P) No. 6/84/Home dated 18.1.1984.

2. If sufficient number of suitable candidates are not available from the Departmental candidates to fill up the Quota reserved for them the deficiency will be made good by selection from the Open Market.

3. The principles of rules of reservation and rotation prescribed in Rules 14 to 17 of part II of the Kerala State and Subordinate Service Rules will not apply for this category. Candidates under this category will be advised on the basis of

merit only. Departmental candidates who are eligible to apply for open market and can apply either for the Quota reserved for them or for Open Competition. But they cannot apply for both categories at a time.

**7. Qualifications:**

- a) Must be a Graduate

**Note:** In the case of Scheduled Caste/Scheduled Tribe candidates, if sufficient number of fully qualified candidates are not available applications of those who have passed Pre University/Pre Degree or equivalent Examinations of recognised University shall be considered only to fill up the quota reserved for them under Category I.

Such candidates may apply in Category No 269/08.

- b). Physical Conditions:

Must be physically fit and should possess the following minimum physical standards.

- (i) Height : 167 cms (Taller persons will be given preference)

- (ii) Chest : 81 cms with minimum expansion of 5 cms.

**Note:-** For Scheduled Caste/Scheduled Tribe candidates the minimum height and chest measurements shall be 160 cms and 76 cms respectively.

- (iii) Should be certified to possess the visual standard specified below without glasses

**NOTE:-** a) Each eye must have full field of vision

b) Colour blindness, squint or any morbid condition of the eye or lids of either eye shall be a disqualification.

c) Candidates should be free from apparent physical defects like knock knee, flat feet, varicose veins, bowlegs deformed limbs, irregular and protruding teeth, defective speech and hearing etc.

(iv) Candidates should produce at the time of interview a Medical Certificate in original in the form prescribed here under certifying to their physical fitness and eye sight without glasses. The Medical Certificate should be one obtained from a Medical Officer not below the rank of a Civil Surgeon.

**Note:-** Details regarding standards of vision should be clearly stated in the certificate, as given above, and vague statements such as vision "normal", etc. will not be accepted. Specification for each eye should be stated separately. If the specifications are not as indicated above, the Officer issuing the certificate should certify whether the candidate has got better standards of vision or worse standards of vision, case may be, otherwise the Certificate will not be accepted.

(v) In addition to the qualification, prescribed above every candidates will be subjected to a physical efficiency test. (The physical measurements of the candidates will be taken before conducting physical efficiency test and those who do not possess the prescribed physical measurements will not be permitted to participate in the physical efficiency test. Candidates must qualify atleast five of the undermentioned eight events of one star standard which is the minimum requirements for recruitment.

**Conditions of Service:-** Those candidates selected will be on training for one years in the department. They will be paid a stipend at a rate of minimum of basic pay plus usual allowances attached to the post during the entire period of

training. The period of training will not be counted for probation. On appointment they will be on probation for a period of two years on duty within a continuous period of three years. Every person appointed to the post shall execute a bond before he joins for training to the effect that he shall serve the department for a minimum period of five years.

8. Applications:- The applications can be submitted only by online facility only provided in the Website of Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of Kerala Public Service Commission viz. [www.keralapsc.org](http://www.keralapsc.org). No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondences. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the Website will be summarily rejected.
