1. The genuiness of the certificate will be subjected to verification and if found bogus, legal action will be taken against the authorities who issued and the candidates who produce the certificate.
  2. The experience certificate produced from institutions other than Government should be got countersigned by the Controlling Authority/ Administrative Authority of Government Department who is authorised to inspect the institution.

6 Age limit 1

For Recruitment By Transfer : No upper age limit is prescribed for recruitment by transfer.

2 For Direct Recruitment : Must have completed twenty two (22) years and must not have completed Thirty Five (35) years of age as on 01.01.2008. Usual relaxations in upper age limit shall be allowed to Scheduled Caste/Scheduled Tribe and Other Backward Classes.

(For conditions regarding age relaxation. Please see Part II of this notification)

- 7 **Qualifications for recruitment by Transfer and Direct Recruitment :-**
- 1 Master's Degree in the concerned subject or discipline with at least 55% (fifty five) marks or its equivalent and good academic records.
  - 2 M.Ed Degree with knowledge of special methods of teaching the subject.
  - 3 Three years teaching experience in schools or colleges after acquiring the professional qualification.
  - 4 Must have passed a comprehensive test specifically conducted for the purpose by U.G.C. or any agency duly constituted by the State Government in this behalf. When qualifications are equal, preference shall be given to candidates who possess adequate knowledge in Malayalam.

**Note:** For recruitment to various posts of Lecturers, Degree awarded by the Universities recognized by the U.G.C. alone shall be considered.

- Exemptions :**
- 1 For SC/ST candidates minimum 50% marks for Masters Degree shall be sufficient (G.O.(MS) No. 2/07/H.Edn.Dated 04.01.2007.)
  - 2 For Ph.D holders who have passed Masters Degree prior to 19.09.1991 50% marks for Masters Degree shall be sufficient (G.O.(MS) No. 2/07/H.Edn Dated 04.01.2007)
  - 3 The candidates who have passed M.Phil. Degree by 31.12.1993 are exempted from possession of NET. (G.O. (P) No. 123/2002/H.Edn. Dated 17.09.2002).
  - 4 The candidates having Ph.D Degree in the concerned subject are exempted from NET (G.O.(P) No. 86/07/H.Edn. Dated 19.06.2007)

**Reservation:** Rules of reservation provided under Rules 14 to 17 of Part II of the KS & SSR 1958 are not applicable in the case of **Recruitment by transfer** from Headmasters, HSAs, and HSS Teachers.
