2. Name of post : Junior Assistant/Cashier (SR for SC/ST)
3. Scale of pay : Rs.4160-7825/-
4. No. of vacancies : 3 (Three)

Note: The above shown vacancies are now existing. The list of selected candidates published by the Commission shall remain in force for a minimum period of One year and a maximum period of Three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment during the pendency of the list. Candidates against vacancies reported exclusively for S T will also be advised from this list and only in the absence of S T Candidates in this list that fresh notification reserved exclusively for Schedules Tribes will be issued.

5. Method of appointment : Direct Recruitment
(From among Scheduled Castes/Scheduled Tribes only)

Note: Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age limit : Should have completed 18 (Eighteen) years and should not have completed 40 (Forty) years of age as on 01.01.2008. (No other age relaxation will be allowed)

Note: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications: - Graduation of a recognized University or equivalent qualification.

8. Application

The applications can be submitted only by on-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age and community have to be produced as and when called for. Application which are not submitted not in accordance with the instructions given in the website will be summarily rejected.
