The candidates included in the ranked list for Direct Recruitment will be advised only if vacancies remain after advising all the candidates included in the ranked list for By Transfer recruitment. The lists of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said lists will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said lists against the vacancies noted above and those that may be reported to the Commission in writing during the currency of the lists.

6. Age Limit: (i) By Transfer Recruitment: Maximum age limit shall in no case exceed 50 (fifty) years as on 01.01.2009.

(ii) Direct Recruitment: Must have completed 18 (eighteen) years of age and must not have completed 35 (thirty five) years of age, as on 01.01.2009 with usual relaxation to scheduled castes, scheduled tribes and other backward communities.
