Note: (i) The selection process and the number of candidates included in the list are to be decided on the basis of the availability of qualified candidates.

(ii) The above vacancies are now in existence. The list of selected candidates published by the Commission in pursuance to this Notification shall remain in force for a minimum Period of one year and a maximum period of three years provided that the list will not continue to be in force if a new Ranked list after the minimum period of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked list.

(iii) The Kerala Public Service Commission shall have the power to cancel the advise for appointment of any candidates to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

6. Age limit : Must have completed 18(Eighteen) years and must not have completed 38 (Thirty eight) years of age as on 01.01.2009 with usual relaxation to SC/ST/OBC

Note: (i) 50% of the vacancies are reserved for suitable and qualified employees of the corporation who have not completed 45 years. The above benefit is restricted only to the employees who were in the service of the Corporation before 28/06/1973 ie. The date on which the special rules came in to force. They must write 'Departmental Candidate' on the top of the cover and application. If they possess all the qualifications required, they can apply for the post as an open candidates also. Separate application should be sent for departmental and open quota. The above mentioned candidates should obtain a certificate in the form shown below and produce it as and when required by the Commission.

The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern.
