1. Concern : Kerala State Road Transport Corporation
2. Name of post : Lower Division Clerk (Special Recruitment from SC/ST)
3. Scale of pay : Rs. 3050-6075
4. No. of vacancies : 6 (Six)

An OMR examination is likely to be conducted as the first phase of selection. In such a circumstance a probability list will be published on the basis of marks secured in the OMR test, by including not less than 50 candidates in the Main List with necessary Supplementary List as per rules.

Note: The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribe for vacancies reserved exclusively for them will be issued.

5. Method of appointment : Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes only)

Note : Applications received from candidates other than Scheduled Caste/ Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age limit : Should have completed 18 (Eighteen) years and should not have completed 40 (Forty) years of age as on 01.01.2009. (No other age relaxation will be allowed for this selection.)

Note : In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications:- Must have passed S.S.L.C. or any equivalent examinations.

8. Method of submitting application :- The applications can be submitted by On-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form from the Website shall be quoted in all further enquires/correspondence. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected. Copies of documents to prove educational qualifications, age, community etc. should be produced as and when called for by the Commission.

9. Last Date for receipt of applications : 04/11/2009 Wednesday upto 05.00 p.m.

11. Paragraphs two, three and twenty seven (except the conditions laid down in the Rule 3(c) of Part II of the Kerala State and Subordinate Services Rules) are not applicable to this selection.

Appointments are made subject to the rank secured in the Ranked List of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.MS.No.142/72/PD dated, 13.04.1972, G.O.MS No.309/73/PD dated, 29.11.1973, G.O.(P)No.21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled caste and Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under Sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
