1. Name of the firm : The Plantation Corporation of Kerala Limited

Note:- (i) The ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked list published on 05.12.2007 for the post.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment

Note:- Application submitted by candidates other than OBC community will be summarily rejected. No rejection memo will be issued to these candidates.

6. Age Limit : Must have completed 21(twenty one) years of age and must not have completed 41 (Forty One) years of age as on 01.01.2009

Note:- (1) The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the commission. It would also be clearly specified in the certificate that they were not working in the regular service in the concern.

7. Qualifications

1. A degree in Arts/Science/Commerce of a university recognized by the Government of Kerala.
2. A degree or diploma in any of the social science from any institution recognized by the Government in this regard.
3. Adequate knowledge in Malayalam.
