1. Department : Kerala State Planning Board
2. Name of Post : Programmer
3. Scale of Pay : Rs.13,610 - 20,700
4. Number of Vacancies : 1 (One)

The above vacancy is now in existence. The Ranked List of selected candidates published by the Commission in response to this Notification shall remain in force for a minimum period of one year provided the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancy noted above and the vacancies that may be reported to the Commission in writing during the currency of the Ranked List.

5. Method of Appointment : Direct Recruitment

6. Age limit:- Must have completed 25 (Twenty five) years of age and must not have completed 45 (Forty five) years of age as on 01/01/2009. Usual age relaxations in upper age limit shall be allowed to SC/ST/OBC candidates [For conditions regarding the age relaxations please see Para (2) of the General conditions in Part II of the Gazette Notification]

Note:- The upper age limit for recruitment to the post shall in the case of any candidate already in the Department including SC/ST/OBC, be 50 years

7. Qualifications:-
  1. First or Second Class Masters Degree in Statistics or Mathematics and Diploma in Computer Science.  
OR  
M.Stat. Degree with specialisation in Computer Science
  2. Five years experience in Computer Programming.

Note:- I

(1) Only a pass in Masters Degree in the concerned subject is necessary in the case of candidates already in the Department.

(2) The qualification of experience shall be the one obtained after the acquisition of academic qualifications prescribed for the post.

(3) Candidates belonging to SC or ST need not possess the qualification of experience prescribed for the post

: (4) Experience Certificate shall be produced by the candidates as and when required by the Commission

Note:- II

(1) The genuineness of the certificate shall be subjected to verification and legal action will be initiated against those who issue and produce the bogus certificate.

(2) The experience certificate produced from institution other than Government should be got countersigned by the Controlling authority/Administrative authority of the Government Department who is authorized to inspect the institution.
