1. Name of the firm/Department : Local Self Government Department.
2. Name of post : Assistant Engineer/Assistant Town Planning Officer
3. Scale of pay : Rs.11070 - 18450/-
4. No. of vacancies : 82 (Eighty two)

Note: (i) The above vacancies are now in existence. The Ranked List/ Short List will be published according to the availability of qualified candidates. This list of selected candidates published by the Commission in pursuance to this notification shall remain in force for a minimum period of One year and a maximum period of three years provided that the list will not continue to be in force if a new Ranked List after the minimum period of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked list.

(ii) The Kerala Public Service Commission shall have the power to cancel the advise for appointment of any candidates to the above post, if it is subsequently found that such advice was made under some mistake, On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

6. Age limit : Must have completed 18 (Eighteen) years and must not have completed 35 (Thirtyfive) years of age as on 01.01.2009 with usual relaxation to SC/ST/OBC

3. Scale of Pay : 11070 - 18450/-
4. Number of Vacancies : 9 (Nine)
5. Age limit : The candidates for direct recruitment from service shall be exempted from the upper age limit fixed for direct recruitment.
6. Method of Appointment : By transfer from the category of First Grade Overseer in the Kerala Local Self Government Engineering subordinate Service.

Note:- The appointment by transfer shall be in the ratio of 3:1 from among the Diploma holders and certificate holders in the feeder category.

7. Qualification :-i) from Diploma holders

- a. Diploma in Civil Engineering or any other qualification recognized as equivalent.
b. Minimum 2 years service as First Grade Overseer.

ii) From Certificate holders

- a. Must have passed SSLC or its equivalent.

(ii) Diploma in Craftmanship in the trade of Draftsman (Civil) obtained after 18 months course followed by six months practical training at the Industrial Training Institute/Centers conducted by Government of India, Ministry of Labour,
(iii) Diploma (2 years course) in Civil Engineering in Womens Polytechnic
c. Minimum 5 years service of which not less than 2 years as First Grade Overseer
