- (i) Provisional Registration with any Medical Council will not be accepted.**
 - (ii) Candidate who has secured Permanent Registration with other State/Central Medical Council will have to get themselves registered under the Travancore-Cochin Medical Practitioners Act before they join duty in the post.**
 - (iii) Candidates who are appointed in the post should serve for 4 (four) years during the first 10 (ten) years of their service (including the period of training) anywhere in India or in any foreign country under Defence Service or assignments connected with Defence. This compulsory service is not applicable to those who have completed 45 (forty five) years of age.**
