Note: The ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment for ST only during the currency of the ranked list.

5. Method of appointment : Direct Recruitment (Special Recruitment from among Scheduled Tribes only)

Note : Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. **Age limit** : Should have completed 19 (Nineteen) years and should not have completed 45 (fortyfive) years of age as on 01.01.2009 (No other age relaxation will be allowed)

Note : 1. There shall be no maximum age limit in the case of persons employed in the department of Indian Systems of Medicine and Ayurveda Colleges. But in no case the maximum age limit shall exceed fifty (50) years.

2. In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. **Qualifications:** 1. A Degree in Ayurveda of a recognized University or equivalent qualification.

2. 'A' class Registration with the Council of Indigenous Medicine of the state.

Note:- Diploma in Ayurveda is considered as sufficient qualification in case of incumbents in service on 05.04.2005.

8. Method of submitting application

The applications shall be submitted only by On-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form from the Website shall be quoted in all further enquires/correspondence.

Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected

9. Last Date for receipt of applications : 03/02/2010 Wednesday upto 5.00 p.m.

11. Paragraphs two, three and twenty seven (except the conditions laid down in the Rule 3(c) of Part II of the Kerala State and Subordinate Services Rules) are not applicable to this selection.

Appointments are made subject to the rank secured in the Ranked List of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P)No.21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/ GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under Sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
