Note: The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from among ST only during the pendency of the list.

5. Method of appointment : Direct Recruitment (from among Scheduled Tribes only)

Note : Applications received from candidates other than Scheduled Tribe will be rejected. Individual communication regarding the rejection of their applications for the above reason will not be issued.

6. Age limit : Should have completed 18 (Eighteen) years and should not have completed 40 years as on 01.01.2009 (No other age relaxation will be allowed)

Note : In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications: Diploma in Mechanical Engineering or Technology awarded by a University, Government or Government recognised body after three years course of study.

8. Method of submitting application

The applications can be submitted only by On-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form from the Website shall be quoted in all further enquires/correspondence. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected

Copies of documents to prove educational qualifications, age, community etc. should be produced as and when called for by the Commission.
