**Note:** The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribe for vacancies reserved exclusively for them will be issued.

5. Method of appointment : Direct Recruitment (Special Recruitment from among Scheduled Castes/ Scheduled Tribes only)

**Note:** Applications received from candidates other than Scheduled Caste/ Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age limit : Should have completed (18) Eighteen years and should not have completed Forty (40) years as on 1.1.2009 (No other age relaxation will be allowed)

**Note:** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

**7. Qualifications:**

- 1) A Pass in Form III or equivalent Qualification
- 2) Recognised Trade Certificate in Sheet Metal Trade  
OR  
Pass in THSLC with specialization in Sheet Metal Trade.

**8. Method of submitting application**

The applications can be submitted only by On-line facility provided in the website of the Kerala Public Service Commission.
