6. Age Limit : Must have completed 21 (twenty one) years of age and must not have completed 44 (forty four) years of age as on 01.01.2009.

7. Qualifications:- Note (i) Candidates who have registered themselves with other State/Central Medical Council may also apply. But they should get themselves registered with the Travancore Cochin Medical Council before taking up employment under Kerala Government Service.

(ii) The candidates appointed to this post shall if and when called for and subject to their being found medically fit by the Defence Authorities are liable to serve for a minimum period of 4 years (including periods spent on training) in the Defence Services or assignments relating to Defence efforts any where in India or abroad not withstanding that at the time of requisition they are holding higher appointments. The liability to serve in the Defence Services will be limited to first 10 years of service and will not ordinarily be applicable to Medical Officers above 45 years of age.
