The above vacancy is now in existence. The Ranked list published by the Commission in response to this Notification shall remain in force for a minimum period of one year provided that the said list will continue to remain in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies that may be reported to the Commission in writing during the period of currency of the list.

5. Method of appointment : Direct Recruitment
6. Age limit : Must have completed 22 (Twenty Two) Years and must not have completed 40 (Forty) years of age as on 01.01.2009 with usual relaxations to SC/ST/OBC candidates.

(For conditions regarding the other age relaxations, please see Para (2) of the General Conditions).

7. Qualifications:

- (1) Masters Degree in the concerned subject with at least 55% marks or its equivalent and good academic record.
- (2) Must have passed a Comprehensive Test in the concerned subject, specifically conducted for the purpose by U.G.C or any agency duly constituted by the State Government in this behalf. When qualifications are being equal, preference shall be given to candidates who possess adequate knowledge in Malayalam.

- NOTE** (i) For SC/ST candidates minimum 50% marks for Masters Degree shall be sufficient.
- (ii) For Ph.D holders who have passed Masters Degree prior to 19-09-1991, 50% marks for Masters Degree shall be sufficient.
- (iii) Candidates who have passed M.Phil Degree by 31/12/1993 or have passed Ph.D in the concerned subject are exempted from passing the NET Examination.
- (iv) For recruitment to the above post, Degrees awarded by Universities recognized by UGC alone shall be considered.

8. Method of submitting Application:-

The application can be submitted only through On-Line facility from 14.01.2010 provided in the Website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the Website of the Kerala Public Service Commission viz.www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
