**2. Name of Posts:** 1) Lecturer in Home Science (Extension Education)-Category No. 488/2009  
2) Lecturer in Electronics - Category No. 489/2009  
3) Lecturer in Journalism- Category No. 490/2009

**3. Scale of Pay : Rs.8,000 - 13,500/-**

**4. Number of Vacancies :** 1) Lecturer in Home Science (Extension Education)- Anticipated  
2) Lecturer in Electronics - 7  
3) Lecturer in Journalism - 2

The above vacancies are now in existence. The lists of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said lists will continue to be in force till the publication of a new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said lists against the vacancies noted above and those may be reported to the Commission in writing during the period of currency of the lists.

**5. Method of appointment : Direct Recruitment**

**6. Age limit : Must have completed 22(Twenty-Two) years of age and must not have completed 40 (Forty) years of age as on 01.01.2009.**

(for conditions regarding the age relaxations please see Para 2 of the General Conditions).

**7. Qualifications:-**

- (1) Masters Degree in the concerned subject with atleast 55% marks or its equivalent and good academic record.
- (2) Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the State Government in this behalf when qualifications are being equal preference shall be given to candidates who possess adequate knowledge in Malayalam.

**Note:-** (i) Candidates who have passed MPhil Degree in the concerned subject by 31.12.1993 or have passed PhD in the concerned subject are exempted from passing the NET Examination.

(ii)For SC/ST candidates minimum 50% marks for Masters Degree shall be sufficient.

(iii)For PhD holders who have passed Masters Degree prior to 19.09.1991, 50% marks for Masters Degree shall be sufficient.

(iv)For recruitment to the above post, Degree awarded by Universities recognised by UGC alone shall be considered.

**8. Method of submitting Application:-**

Applications should be submitted by On-line facility from 14/01/2010 provided in the Website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the Website of Kerala Public Service Commission
