6. Age Limit : Must have completed 25(twenty five) years of age and must not have completed 46 (forty six) years of age as on 01.01.2009, with usual relaxation to scheduled castes, scheduled tribes and other backward communities.

7. Qualifications:-

1. First or Second class Master's Degree with a minimum of 50% marks in Anthropology/Sociology acquired after a regular course of study from a recognized University.
2. Ph.D. in any of the above subjects with field experience in the respective subjects preferably in Scheduled Castes/Scheduled Tribes subjects; and
3. Minimum 10 years Research/Teaching experience, after Post Graduation, on subjects related to Scheduled Castes and Scheduled Tribes.

Note: 1. The experience should be one acquired after the acquisition of the basic qualification.
