4. Method of appointment : Direct Recruitment (Recruitment from candidates belonging to reservation groups of Kerala state only mentioned in this notification)

Note:- Application of candidates belonging to other than the communities mentioned in this notification will be summarily rejected and individual rejection memo will not be sent to them.

5. Age limit : Must have completed 22 (Twenty Two) Years and must not have completed 43 (forty three) years of age as on 01.01.2009

[for conditions regarding the other age relaxations, please see the General Conditions - except Para 2 (i)].

6. Qualifications:

1. Masters Degree in the concerned subject with at least 55% marks or its equivalent and good academic record.

2. Must have passed a Comprehensive Test in the concerned subject, specifically conducted for the purpose by U.G.C or any agency duly constituted by the State Government in this behalf. When qualifications are being equal, preference shall be given to candidates who possess adequate knowledge in Malayalam.

Note:-

(i).For Ph.D holders who have passed Masters Degree prior to19-09-1991, 50% marks for Masters Degree shall be sufficient.

(ii)Candidates who have obtained Ph.D Degree in the concerned subject or have passed M.Phil Degree in the concerned subject by 31.12.1993 are exempted from passing the NET Examination.

(iii)Whenever the requirement is for a Lecturer in particular subject to be taught in Sanskrit, candidates with M.A (Special) in the subject to be taught alone shall be eligible for selection.

(iv) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.

7. Method of submitting Application:-

The application can be submitted by On-Line facility only from 14.01.2010 provided in the Website of the Kerala Public Service Commission. viz.www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age, community etc. have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
