2. Name of Post : Physical Education Teacher (UPS) (Malayalam Medium)

**Note:-** (1) Vacancies reported in writing from the schools under the control of Local Self Government Institutions shall also be filled up from the Ranked List prepared as per the notification for Direct Recruitment

(2) Conventional type application for the above post will be summarily rejected. Candidates can apply through on-line application available at the Kerala Public Service Commission website.

(3) Separate ranked list will be prepared for each district in pursuance of this notification. The ranked lists thus prepared and published by the Commission shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earliest.

4. The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(Ms) No.154/71/PD dated 27.5.1971. A candidate advised for appointment in one Revenue District from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(Ms)No.4/61/PD dated 2.1.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of Appointment : Direct Recruitment

6. Age limit : Should have completed 18 (Eighteen) years and should not have completed 39 (Thirty nine) years of age as on 01.01.2009 with usual relaxation to Scheduled Caste/Scheduled Tribe and Other Backward Communities.

**Note:-** For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the general conditions under Part II of this notification.

**7. Qualifications:-** 1. A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

2. A pass in the Certificate of Physical Education issued by the Commissioner for Government Examinations, Kerala or a pass in the Vocational Higher Secondary Education in Physical Education conducted by the Board of Vocational Higher Secondary Educations, Kerala or its equivalent or any degree in Physical Education (Regular Course) such as B.P.Ed /M.P.Ed. etc., conferred or recognized by any of the Universities in Kerala (G.O.(Ms.) No. 48/2001/G.Edn dated 9.2.2001).

Ex-servicemen of Army/Navy/Air Force who possess one of the following qualifications can also apply for the post.

“Physical Training Course of the Armed Forces” (The Assistant Instructors Basic Course in Physical Education)

OR

The Army Physical Training Instructors Corps Course

OR

Naval Physical Training Corps Instructors Course

OR

Air Force Ground Training Instructors Course, provided that such Ex-service personnel shall also possess SSLC or its equivalent qualification.

Note:- Physically Handicapped persons are not eligible to apply for this post.

#### 8. Special Concessions Regarding Appointment and Age Limit --

1. Preference will be given as laid down in G.O (Ms) No.50/70/PD dated 12.2.1970 and G.O (Ms) No.9/78/G. Edn. Dated 21.01.1978 to the Wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base establishment are included under the term of Jawans, Wives of Jawans must select “Are you entitled to any priority” as ‘Yes’ on on-line application and give the details in the following space. Such candidates should produce proper certificates from the officer commanding stating the name, Military rank and Military address of their husbands and produce the same as and when required by the Commission [(G.O (Ms) No.509/ 64/Edn. dated 19.09.1964, G.O (Ms) No.614/ 65/Edn.dated 09.11.1965 and G.O (Ms) No.243/66/Edn. Dated: 27.05.1966)].

2. Laboratory Attenders in the Departmental High Schools in the State who have rendered atleast five years satisfactory service and who possess the prescribed qualification will be exempted from age limit. They should produce proper certificates from the Headmaster of the School specifying the date of commencement of their service and the total service put in by them and produce it as and when required by the Commission. The candidates who claim exemption on this basis will not be given the benefit of communal reservation and will be considered only against vacancies to be filled up by open competition on the basis of merit alone. [G.O. (Ms.) 315/62/Edn.dated 14.5.1962].

3. First Class Scouts and Guides will be given preference in the matter of appointment as Teachers [G.O. (MS) No. 122/75/ G Edn. dated. 27.5.75].

4. Those who have acquired the prescribed qualification on or before 28.6.1975 are eligible for relaxation of the maximum age limit to the extent of 6 years [G O (M.S.) No.55/78/G.Edn. dated 8.5.1978].

**Note:-** The candidates who claim concessions in lieu of any of the above reasons should select "Are you eligible for age relaxation" as 'Yes' on the on-line application and give details in the following space. (For other conditions regarding age relaxation please see Para 2 of the General conditions) Upper age limit after allowing age relaxation as per rule should not exceed 50 years.

9. Last date of receipt of applications: 17/02/2010 Wednesday up to 5.00 PM.

10. Candidates are allowed to submit the application by on-line only:-

Applications should be submitted by on-line facility from 14.01.2010 provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of the application are available in the website of the Kerala Public Service Commission viz. [www.keralapsc.org](http://www.keralapsc.org). No application fee is required. The barcode number in the application form shall be quoted in all further enquiries and correspondences. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.
