5. Method of appointment : Direct Recruitment (Special Recruitment from among Scheduled Tribes only)

Note:- Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age Limit : Should have completed 18 (Eighteen) years and should not have completed 40(Forty) years of age as on 01.01.2010.(No other age relaxation will be allowed.)

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualification: 1. Pass in Standard VI (New) or its equivalent.  
2. Desirable:- 3 years service in the defence service.

8. Method of submitting application:- The application can be submitted by On-line facility provided in the website of the Kerala Public Service Commission.
