**Note:-** The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from ST only during the pendency of the list.

5. Method of appointment : Direct Recruitment  
(from among Scheduled Tribes only).

**Note:-** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age Limit : Should have completed 18 (Eighteen) years and should not have completed 40 (Forty) years of age as on 01.01.2010. (No other age relaxation will be allowed).

**Note:-** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications :-
  - 1) Pass in Std. VII (New)
  - 2) Knowledge of Cycling.

8. Method of submitting application :
