1. Name of the firm : Kerala State Housing Board

NOTE: (i) The above vacancies are now in existence. The number of candidates to be included in the Probability list/Short list will be decided later according to the availability of qualified candidates in pursuance to this notification. This list of selected candidates published by the Commission in pursuance to this notification shall remain in force for a minimum period of one year and a maximum period of three years provided that the list will not continue to be in force if a new Ranked List after the minimum period of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked List.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of his/her probation or 240 days from the date of his/her joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment

6. Age limit : Must have completed 18 (Eighteen) years of age and must not have completed 35 (Thirtyfive) years of age as on 01-01-2010 with usual relaxation to SC/ST/OBC.

Note: (i) The regular employees working in the above concern will be given age relaxation to the extent of their service in the board from the upper age limit, if they possess prescribed qualification.

Must possess B.A./B.Sc./B.Com. or its equivalent degree from a recognized University after a regular course of study and Certificate in Computers (3 months course) from an Institution recognized by Government.
