SECOND RENOTIFICATION

1. Department : Health Services
2. Name of post : Dental Hygienist
3. Scale of pay : Rs.6680-10790/-
4. Number of vacancies : Scheduled Tribe -1 (one)
Latin Catholic - 2 (Two)
OX - 1 (One)
Dheevara - 1 (One)

The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for ST, LC, OX and Dheevara communities as unfilled due to paucity of candidates during the currency of the Ranked list, published on 29.11.2005 for the post (Category No.253/2004). This is the second renotification due to the nonavailability of candidates for the post as per notifications dated, 04.09.2007 (Category No.294/2007) and 10.09.2008 (Category No.325/2008).

5. Method of appointment : Direct Recruitment (from among ST, LC, OX and Dheevara communities only).

Note:- (1) In the absence of Scheduled Tribe candidates, the application of Scheduled Caste candidates will also be considered.

(2) Application submitted by candidates belonging to other than SC, ST, LC, OX and Dheevara Communities will be rejected. No rejection memo will be issued to them individually.

6. Age Limit: SC/ST candidates born between 2.1.1970 and 1.1.1992 (both dates included) and LC, OX and Dheevara candidates born between 2.1.1972 and 1.1.1992 (both dates included) are eligible to apply for this post.

Candidates who were adult members of SC Community converted to Christianity and their children belonging to OX Community are eligible for age relaxation upto 40 years.

(For conditions regarding other age relaxation please see para 2 of the General Conditions, except Para 2(i))

7. Qualifications:

1. Pass in SSLC or its equivalent.
2. Pass in Dental Hygienist Course conducted in the Dental College, Thiruvananthapuram or its equivalent.

8. Mode of submitting Applications:

The applications should be submitted only through on-line facility provided in the Website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of Kerala Public Service Commission viz. www.keralapsc.org No application fee is required. The barcode number in the application form from the Website shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age and community have to be produced as and when called for. Application which are submitted not in accordance with the instructions given in the website will be summarily rejected.
