**Note:-** 1. A Ranked list will be prepared for Kozhikode district in pursuance of this notification. The Ranked lists thus prepared and published by the Commission shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till, the publication of new lists after the expiry of the minimum period of one year or till the expiry of the three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked lists till the expiry of the period of three years the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

2. The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in the revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS) No.4/61/PD dated 02.01.1961.

Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment

6. Age Limit : 35-45. Only candidates born between 02.01.1965 and 01.01.1975 (both dates included) are eligible to apply for this post. Other Backward communities and SC/ST candidates are eligible for usual age relaxation.

**Note:-** For concessions allowed in upper age limit, Subject to the condition that the maximum age limit shall in no case exceed 50 years, please see Para (2) of the General Conditions under Part II of this notification.

7. Qualifications : -

Essential:- Pass in Form IV

Desirable:- 1. Experience as Female House Keeper, Female Assistant, House Keeper or Matron in a Hostel or other institution.

2. Knowledge of Accounts.

**Note:-** The applicant should be prepared to stay in the Hostel or institutions to which she is appointed. In the absence of qualified candidates within the above age limits, maximum or minimum age limits will be relaxed in deserving cases.

8) Application Form:-

Applications should be submitted only through On-line facility provided in the Website of the Kerala Public Service Commission. The application forms of the PSC designed for processing through Optical Mark Reader will not be considered for this post. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.
