Note:- 1) Separate ranked list will be prepared for each district in pursuance of this notification. The ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked lists till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

2) Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should note the name of that District against the relevant column.

3) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(MS) No.154/71/PD dated, 27.5.1971. A candidate advised for appointment in the Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in GO(MS) No. 4/61/PD dated, 2.1.1961.

Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment
6. Age : 20-35
Only candidates born between 02.01.1975 and 01.01.1990 (both dates included) are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age relaxation.

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para(2) of the General Conditions under Part II of this Notification.

7. Qualifications:

1. A pass in Plus Two/Pre-degree (with Science Subjects) Course/Pass in VHSE (with Science subjects)/ and VHSE in Domestic Nursing of a recognized University or its equivalent.
2. A Pass in B.SC Nursing of a recognized University or a pass in General Nursing and Midwifery Course having not less than 3 years duration from any institution recognized by Government.
3. Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and Midwife, in the case of Women candidates and as Nurse in the case of male candidates.

Note:- Physically Handicapped candidates (Orthopaedic-Lower extremities, partially deaf) are eligible for 3% appointment as per GO(P) No.11/2009/SWD dated, 10.2.2009.

8. Last date for receipt of applications: 08.09.2010 Wednesday upto 5.00.p.m

9. Mode of sending applications:

The applications can be submitted only by online facility provided in the Website of the Kerala Public Service Commission. Detailed instruction regarding the submission of the applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The candidates applying through on-line should keep the print out (Receipt) of their applications and the barcode number shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age, community etc have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
