NOTE:-1. Separate ranked list will be prepared for each district in pursuance of this notification. The ranked lists thus prepared and published by the Commission shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked lists till the expiry of the period of three years the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

2. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should note the name of the District concerned in the relevant column

3. The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in the Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS)No. 4/61/PD dated 2.1.1961.

Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified

4. 3% vacancies for the post shall be reserved for eligible PH candidates vide GO (P)No. 11/2009/SWD dated 10.02.2009 (Orthopaedic-Lower Extremities- Deaf)

5. Method of appointment : Direct Recruitment

6. Age : 18-35 Only candidates born between 2.1.1975 and 1.1.1992 (both dates included) are eligible to apply for this post. SC/ST and OBC candidates are eligible for usual age relaxation.

NOTE:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification

7. Qualifications:-

1. Pass in SSLC or its equivalent qualification
2. ITI Certificate in the trade of Electrician or equivalent qualification
3. Wireman competency certificate/permit issued by the Kerala State

8. Last date of receipt of Applications: 08.09.2010 Wednesday upto 5.00 pm

9. Mode of submitting application:- The application can be submitted only by online facility provided in the website of the Kerala Public Service Commission. Detailed instruction regarding the submission of the applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The candidates applying through online should keep the print out (Receipt) of their applications and the barcode number shall be quoted in all further enquiries/correspondence. Documents to prove qualification, age and community etc have to be produced as and when called for. Applications which are submitted not in accordance with the instruction given in the website will be summarily rejected.
