Applications are invited online only from qualified candidates for the undermentioned post.

1. Department : Ayurveda Colleges
2. Name of post : Nurse Grade II (Ayurveda)
3. Scale of pay : Rs. 6080-9830/-
4. Number of vacancies : District wise
 1. Ernakulam - 2 (Two)
 2. Kannur - 1 (One)

Note:- (i) Separate Ranked list will be prepared for each District in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

2. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the District concerned in the relevant column.

(3) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G O (Ms) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No. 4/61/PD, dated 2.1.1961.

Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment
6. Age limit : (19-35). Only candidates born between 02.01.1975 and 01.01.1991 (both dates included) are eligible to apply for this post. SC/ST and Other Backward Communities are eligible for usual age relaxation.

Note:- For concessions allowed in upper age limit subject to the condition that the maximum age limit shall in no case exceed 50 years, please see Para (2) of the General Conditions under part II of this notification.

7. Qualifications:
 1. Pass in SSLC
 2. Certificate in Ayurveda Nurses' Training Course recognized by the Government of Kerala
 - i) Appointment of male and female candidates will be made in the ratio 1:5 in accordance with the Rules of Reservation and rotation.
 - ii) Physically Handicapped persons are not eligible to apply for the post.

8. Last date for receipt of applications: 15.09.2010 Wednesday upto 5 PM

9. Mode of submitting application:- (I) The applications can be submitted by online facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz www.keralapsc.org. No application fee is required. Documents to prove qualification, age and community have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.
