**NOTE:** 1. A ranked list will be prepared for Idukki and Alappuzha Districts in pursuance of this notification. The ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked lists till the expiry of the period of three years the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

2. Candidates should note the name of the District against the relevant column in the application .

3. The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G. O. (MS) No.154/71/PD dated 27.5.1971. A candidate advised for appointment in the Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O. (MS) No. 4/61/PD dated 2.1.1961.

Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of Appointment : Direct Recruitment

6. Age Limit : 18-35. Only candidates born between 02.01.1975 and 1.1.1992 (both dates included) are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age relaxation.

**NOTE:** -For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. QUALIFICATIONS:

- (i) Pass in SSLC or equivalent qualification
- (ii) Pass in Ayurveda Therapists Course conducted by Government of Kerala

8. Last date for receipt of applications: 15.09.2010 Wednesday upto 5.00 p.m.

9. Mode of submitting applications.

(i) Applications should be submitted by on-line facility provided in the website of the Kerala Public Service Commission Detailed instructions regarding the submission of application are available in the website of Kerala Public Service Commission viz. [www.keralapsc.org](http://www.keralapsc.org). No application fee is required. Documents to prove qualifications, age and community have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will summarily be rejected.
