Ranked list thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the Physically Handicapped persons-(Partially Deaf) turns identified as unfilled during the currency of the Ranked List published for the post in the following district.

3) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(MS) No.154/71/PD dated, 27.5.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in GO(MS) No. 4/61/PD dated, 2.1.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply for higher posts when notified.

5. Method of appointment : Direct Recruitment (from among Physically Handicapped (Partially Deaf) candidates only)

Note: Application submitted by candidates other than those belonging to Physically Handicapped (Partially Deaf) will be summarily rejected. No rejection memo will be issued to them individually.

6. Age : 20-35. Only Candidates born between 2.1.1975 and 1.1.1990 are eligible to apply for this post. (Both dates included) with usual relaxation to Scheduled Caste/ Scheduled Tribe, Other Backward Communities.

Note: For details regarding other age relaxations, subject to the condition that the maximum age limit shall in no case exceed 50 (Fifty) years, please see para(2) of the General Conditions under Part II of this Notification.

7. Qualifications:

1. A pass in Plus Two/Pre-degree (with Science Subjects) Course/Pass in VHSE (with Science subjects) /and VHSE in Domestic Nursing of a recognized University or its equivalent.
2. A Pass in B.SC Nursing of a recognized University or a pass in General Nursing and Midwifery Course having not less than 3 years duration from any institution recognized by Government.
3. Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and Midwife, in the case of Women candidates and as Nurse in the case of male candidates.

8. Last date for receipt of applications: 15.09.2010 Wednesday upto 5.00.p.m

9. Candidates are allowed to submit the application by Online only.

Applications should be submitted by Online facility provided in the website of the Kerala Public Service

Commission. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age, community etc have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.
