SECOND NCA NOTIFICATION

1. Name of the Firm : Plantation Corporation of Kerala Ltd.
2. Name of Post : Assistant Manager

NOTE: (i). The above vacancies are existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above Communities but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 23.03.2000 for the post. This is the second NCA Notification published due to the non-availability of candidates as per the notification in the gazette dated 14.02.2008 under category No.80/2008 for the post.

(ii) The Kerala Public Service Commission shall have the power to cancel the advise for appointment of any candidates to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of Appointment: Direct Recruitment (from among L.C., SC and OBC Communities)

NOTE:- Applications submitted by candidates other than L.C., SC and OBC will be summarily rejected. No rejection memo will be issued to these candidates. In the absence of SC candidates ST candidates will be considered. Therefore ST candidates can apply for the post.

6. Age Limit : Must have completed Twenty one (21) years and must not have completed forty (40) years of age as on 1.1.2010.

NOTE: - (1) The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.
