NOTE:(i) The above vacancies are now in existence. (ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

5. Method of appointment : Direct Recruitment

6. Age : (21 - 35). Only candidates born between 2.1.1975 and 1.1.1989 (both dates included) are eligible to apply for this post. OBC and SC/ST candidates are eligible for usual age relaxation.

Note: (1) The provisional hands working in the above concern will be given age relaxation to the extent of the provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

(for other conditions regarding the age relaxation please see para 2(i),(ii),(iii),(iv),(vii) &(xii) of the General Conditions).

7. Qualifications:

- 1) Should possess a Bachelors Degree in Commerce obtained from a recognized university. (B.Com Degree)
- 2) Experience for not less than 2 years in the Accounts matters in Government Department or in an industrial or Commercial Undertaking or Limited Company registered under the companies Act or in a public sector undertakings such as (i) Co-Operative Societies Act (ii) Small Scale Industrial Units registered with the Industries Development Commissioner and (iii) Industrial Institutions where in government have interest.
- 3) Exposure to computer operations is essential.

Note : 1) The experience should have been acquired after obtaining the academic qualification.
