Note: (i) The above vacancies are now in existence. The list of selected candidates published by the Commission in pursuance to this Notification shall remain in force for a minimum period of One year and a maximum period of three years provided that the list will not continue to be in force if a new Ranked List after the minimum period of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of pendency of the Ranked list. Twenty-five percentage of the total vacancies reported for the post will be reserved for Recruitment by transfer.

(ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidates, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made with in the period of probation or 240 days from the date of joining duty whichever is earlier.

5 Method of appointment : Direct Recruitment

6 Age : (19 - 36). Only applicants born between 02.01.1974 and 01.01.1991 (both dates included) are eligible to apply for this post Other Backward Communities and SC/ST candidates are eligible for usual age relaxation.

NOTE: (i) The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hand should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications: -

Must posses any one of the following qualifications.

- (a) Upper Subordinate Diploma of the College of Engineering Guindy.
- (b) Diploma in Civil or Mechanical Engineering of the Travancore (now Kerala) University or Diploma recognized by Government as equivalent thereto.
- (c) Lower Subordinate Diploma of the College of Engineering Guindy.
- (d) Licentiate in Civil or Mechanical Engineering from the Technical Institute at Kozhikode, Trichur, Kalamassery or other equal course.
