Note:(i) Conventional type application for the above post will be summarily rejected Candidates can apply through on line application available at the Kerala Public Service Commission Website.

(ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to those candidates.

(iii) A Ranked list will be prepared for Kasaragod district in pursuance of this notification. Ranked list thus prepared and published by the Commission, shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during currency of the ranked List published for the post in the following districts.

(iv) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (MS)No.154/71/PD., dated 27.5.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G. O. (Ms) No. 4\61\PD., dated 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post.

5. Method of Appointment : Direct Recruitment (from the above mentioned reservation group of community.)

6. Age : (18-42). Candidates born between 2.1.1968 and 1.1.1992 (both dates included) are eligible to apply for this post. (Including the relaxation as per para 2 (I) of General conditions.)

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) except para 2(i) of the general conditions under part II of this Notification.

7. Qualifications:

- (i) A Bachelor's degree or Post Graduate degree in English language and Literature, and
- (ii) B.Ed/B.T with English as optional subject conferred or recognized by any of the Universities in Kerala.

In the absence of those with qualifications in item (ii) candidates with B.Ed/B.T in any other subject conferred or recognized by any of the Universities in Kerala will be considered.

Note:(1) The disciplines in which B.A/M.A and B.Ed Degrees were obtained should be mentioned.

8. Special Concessions Regarding appointment and Age Limit:

- (i) Preference will be given as laid down in G.O(Ms) No.50/70/PD.dated12.02.1970 and G.O(Ms) No.9/78/G.Edn. Dated, 21.01.1978 to the Wives of Jawans in the matter of recruitment as teachers, if they possess the prescribed qualification. Soldiers inactive service and those working in base establishment are included under the terms of Jawans. Wives of Jawans should select "are you entitled to any priority " as "yes" on online application and give the details in the space following

such candidates should produce certificates from the officer commanding stating the name, Military rank and Military address of their husbands and produce the same as and when required by the Commission G.O (Ms) No.509/64/Edn. Dated 19.09.1964, G.O(Ms) No. 614/65/Edn. dated 09. 11. 1965 and G.O(Ms) No.243/66/Edn. dated,27.05.1966).

(ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS)No. 122/75/G.Edn. Dated,27.05. 75.

(iii) Teachers of the Government primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O. MS. No.185/70/Edn. dated 18.04.70 and G.O.MS. No.466/70/Edn. Dated 11.11.70) they should produce proper certificates from authorities concerned, as and when required by the Commission.

Note:-The Candidates who claim concessions in lieu of any of the above reasons should select "Are you eligible for age relaxation" as 'yes' on the on-line application and give details in the following space.

9. Last Date of receipt of applications: 06.10.2010 Wednesday upto 5.00 PM.

10. Candidates are allowed to submit the applications through online only:-

The applications can be submitted by on-line facility provided in the website of the Kerala Public Service commission. Details instructions regarding the submission of applications are available in the website of the Kerala Public Service commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondences. Documents to prove qualification, age and community have to be produced as and when called for. Application which are not submitted in accordance with the instructions given in the website will be summarily rejected.

Note:- Candidates shall take a print out (receipt) of their submitted application and retain the same after entering the barcode number for further communications.
