Note: - (i) Applications submitted by candidates belonging to the Communities other than the notified will be summarily rejected. No rejection memo will be issued to these candidates.

(ii) Separate Ranked Lists will be prepared for each district in pursuance of this notification. Ranked Lists thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post in the following districts.

(iii) Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Reservation community candidates should submit application for this post to the concerned district officer where the vacancy is existing for their respective community and should note the name of that district against the relevant column.

(iv) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G O (Ms) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No. 4/61/PD, dated 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from Muslim, SC, SIUC N/AI, community only).

6. Age : SC : 20-40,
Muslim, SIUC N/AI : 20-38

Scheduled Caste candidates born between 02.01.1970 and 01.01.1990 (both dates included) and Muslim, SIUC N/AI candidates born between 02.01.1972 and 01.01.1990 (both dates included) are eligible to apply for this post.

Note:- (Including the relaxation as per para 2(i) of General Conditions). For candidates regarding other age relaxation please see para 2 of the general conditions except 2 (i).

7. Qualifications:

1. A Pass in Plus/Pre-Degree (with Science subjects) course/pass in VHSE (with science subjects)/and VHSE in Domestic Nursing of a recognised University or its equivalent .

2. A pass in B.Sc Nursing of a recognised University or a pass in General Nursing & Midwifery Course having not less than 3 years duration from any institution recognised by Government.

3. Certificate of Registration with Kerala Nurses and Midwives Council as Nurse and Midwife, in the case of woman candidates and as Nurse in the case of male candidates.

8. Last date of receipt of applications : 06.10.2010 Wednesday upto 5 p.m

9. Mode of submitting applications :-The Applications should be submitted by On-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of the application are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The candidates applying through on-line should keep the print out (Receipt) of their applications and the barcode number shall be quoted in all correspondence. Documents to prove qualifications, age, and community are to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
