- 1 Department : Technical Education
- 2 Name of Post : Tradesman (Smithy)
- 3 Scale of Pay : Rs.5250 - 8390
- 4 Number of vacancy : District-wise- Thrissur
Latin Catholic- 1 (One)

NOTE:- 1) Conventional type application for the above post will be summarily rejected. Candidates can apply only through on line application available at the Kerala Public Service Commission website.

2) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to such candidates.

3) Separate Ranked list will be prepared for Thrissur district in pursuance of this notification. Ranked List thus prepared and published by the Commission, shall remain in force until candidates are advised and appointed against all the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked List for the post in Thrissur district published on 28.12.2009 (category No. 373/2007)

4) Candidate should note the name of the above district against the relevant column in the application

5) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS)No.154/71/PD dated 27.5.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five (5) years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five (5) Years, it will be subject to the rules in G.O.(MS)No.4/61/PD dated 2.1.1961. Candidates already in Government Service, holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

6. Method of appointment : Direct Recruitment (From candidates belonging to Latin Catholic reservation community only)

7. Age : 19-39. Only candidates born between 2.1.1971 and 1.1.1991 (both dates included) are eligible to apply for this post. This includes the relaxation as per para 2(i) of General Conditions.

NOTE:- For condition regarding other age relaxation please see para 2 of the general conditions except para 2 (i)

8. Qualifications:-

- 1 Pass in Standard VII
- 2 JTSLC or ITI or KGTE or KGCE or City and Guilds Examination in the concerned trade

Note:- i) The certificates awarded by City and Guilds of London Institute after 31.03.1985 will not be accepted

ii) Candidates should specify the name of the Trade/Branch also along with the qualification in the application .

10 Mode of submitting application :- Candidates are allowed to submit the application by on-line only. Application should be submitted by on-line facility provided in the website of the Kerala Public Service Commission. Detailed instruction regarding the submission of the applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. Candidates are advised to take a print out of their online application and note the barcode number for future reference. The barcode number in the application shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age and community etc have to be produced as and when called for. Applications which are not submitted in accordance with the instruction given in the website will be summarily rejected.
