(2) Permanent Registration under State Medical Council (Travancore Cochin Medical Council)**

Note:- DNB Qualifications must be acquired from a Medical College which is recognised by any of the University in Kerala.

3. Number of vacancies : 13 (Thirteen)

Note: - The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancy noted above and that may be reported to the Commission in writing during the period of currency of the list.

**Qualifications: (i) MBBS Degree from a recognised University
(ii) Permanent Registration under State Medical Council(Travancore Cochin Medical Council)**

Note: - (i) Provisional Registration with any Medical Council will not be accepted.

(ii) Candidate who have secured Permanent Registration with other State/ Central Medical Council will have to get themselves registered under the Travancore-Cochin Medical Practitioners Act before they join duty in the post.

(iii) Candidates who are appointed in the post should serve for 4 (four) years during the first 10(Ten) years of their service (including the period of training) anywhere in India or in any foreign country under Defence Service or assignments connected with Defence. This compulsory service is not applicable to those who have completed 45 (Forty-five) years of age.

4. Method of appointment : Direct Recruitment

5. Age limit: Must have completed 21 (Twenty One) years of age and must not have completed 45 (Forty Five) years of age as on 01.01.2010. (For conditions regarding the age relaxation please see Part II of the General Conditions)
