1. Name of Department : Printing (Government Presses)
2. Name of post : Binder Gr. II (Special Recruitment from Scheduled Tribe only)
3. Scale of pay : Rs.5510- 8590

Note:-

(i) The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of Three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment for Scheduled Tribe only during the pendency of the list.

(ii) The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special Conditions laid down in G.O.(MS) No. 154/71/PD, dated 27-05-1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she completes five (5) years continuous service from the date of commencement of service in former District. Even if transfer is allowed after five (5) years it will be subject to the orders contained in G.O.(MS) No. 4/61/PD, dated 2-1-1961. Candidates already in Government Service holding the post in one District are restricted from applying for the same post in another District. But they can apply for higher posts. Candidates from the Ranked List will be advised for appointment against the Headquarters vacancies also. As per the provision in G.O.(MS) No. 154/71/PD. Dated: 27-05-1971, appointment against the Headquarter vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.

(iii) The name of the District Thiruvananthapuram should be noted in the relevant column of the application.

5. Method of appointment : Direct Recruitment (from among Scheduled Tribes only)

Applications received from non ST candidates will be rejected. Individual communication regarding the rejection of their applications for the above reason will not be issued.

6. Age limit: Should have completed Nineteen(19) years and should not have completed 40 (Forty) years of age as on 01.01.2010. (No other age relaxation will be allowed)

NOTE:- In the absence of qualified candidates within the age limit upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

7. Qualifications :-

- (1) Must have completed S.S.L.C course or its equivalent.
- (2) Must have passed KGTE or MGTE in Book Binding (Lower)

8. Method of Sending Application

The application can be submitted only by online facility provided in the website of the Kerala Public Service Commission.No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondence. Documents to prove qualification,age and community have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.

Appointments are made subject to the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.MS.No.142/72/PD dated, 13.04.1972, G.O.MS.No.309/73/PD dated, 29.11.1973, G.O.(P)No.21/76/PD dated, 17.01.1976 and G.O.(p) No.25/94/GAD dated 22.01.1994, allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under Sections 3(c) 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
