NOTE:- (i) Separate Ranked list will be prepared for each district in pursuance of this notification. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from SC/ST during the pendency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in the list that fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.

(ii) The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special Conditions laid down in G.O.(MS)No.154/71/PD dated 27.5.1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she completes five(5) years continuous service from the date of commencement of service in the former District. Even if, transfer is allowed after five (5) years, it will be subject to the orders contained in G.O.(MS)No.4/61/PD dated 2.1.1961. Candidates already in Government Service, holding the post in one District are restricted from applying for the same post in another District. But they can apply for higher posts.

(iii) Candidates from the Ranked List for district wise selection will be advised for appointment against the Headquarters vacancies also. As per the provision in G.O.(MS)No.154/71/PD, Dated: 27.05.1971, appointment against the Headquarter vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.

(iv) Candidates are not eligible to apply for the same post in more than one District. If a candidates applies to more than one district and gets selected, his/her selection will be cancelled and disciplinary action will be taken against him/her.

5. Method of appointment : Direct Recruitment (SR from among Scheduled Castes/
Scheduled Tribes only).

NOTE:- Application received from non Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communication regarding the rejection of their applications for the above reason will not be issued.

6. Age Limit:- Should have completed 19(Nineteen) years and should not have completed 40 (forty) years of age as on 01.01.2010 (No other age relaxation will be allowed).

NOTE: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit , shall exceed 50 (fifty) years.

7. Qualifications:

A Bachelors Degree either in Economics or in Statistics or Mathematics or Commerce with statistics from a recognized University or Institution.

Probation: Every person appointed to the post shall from the date on which he joins duty be on probation for a total period of two years on duty with in a continuous period of three years.

8. Method of submitting application:

The application can be submitted only by Online facility provided in the Website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the Website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form(from the website) shall be quoted in all further enquiries. Applications which are not in accordance with the instructions given in the website will be summarily rejected. Documents to prove qualifications, age and community have to be produced as and when called for.

9. Last date for receipt of applications : 07/04/2010 Wednesday upto 5.00 pm.

11. Paragraphs two, three and twenty seven of the General Conditions are not applicable to this selection.

12. Appointments are made subject to the rank secured in the Ranked List of candidates prepared in pursuance of this notification subject to the conditions laid down in GO(MS)No.142/72/PD dated,13.4.1972, GO(MS) No.309/73/PD dated, 29.11.1973 G.O.(P)No.21/76/PD dated 17.01.1976 and G.O.(P)No.25/94/GAD dated 22.01.94 allowing Special reservations to Scheduled Castes and Scheduled Tribes and in accordance with the procedures made for this purpose from time to time and subject to the rules under Sections 3(c) , 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
