1. Name of concern : Kerala State Co-operative Bank Ltd.
2. Name of Post : Accounts Officer
3. Scale of Pay : Rs.10975 - 29300
4. No. of vacancy : 2 (Two)

Note:- 1. The above vacancies are now existing in Kerala State Co-operative Bank Limited for Society Category (Part II) alone. Since the same is arrived at by dividing the 4 vacancies at present reported to the Commission between General Category (Part I) and Society Category (Part II) in the proportion of 1:1 ratio with the first turn going to General Category. Vacancies, if any, further reported will also be divided between General Category (Part I) and Society Category (Part II) in the proportion of 1:1 ratio in continuation of the division already made and the vacancies so earmarked for society category under Part II will be filled up from the Ranked List prepared in response to this Notification. The first turn of vacancies is for General Category as per rules.

2. The ranked list prepared and published by the Commission in response to this notification shall remain in force for a minimum period of one year and a maximum period of three years subject to the condition that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Candidates will be advised for appointment against the vacancies which are earmarked for Society Category under Part II during the period of currency of the list.

3. The selection in pursuance of this notification will be made on statewide basis.

5. Method of appointment : Direct Recruitment from eligible employees of Member Societies/Primary Co-operative Societies affiliated to the Kerala State Co-operative Bank Limited.

6. Age Limit : Must have completed 18 (Eighteen) years of age and must not have completed 50 (Fifty) years of age as on 01.01.2010.

7. Qualifications:-

1. Must be a regular employee who has a minimum regular service of 3 (three) years (and continuing in service) in any cadre in the member societies/Primary Co-operative Societies affiliated to the Kerala State Co-operative Bank Ltd.

2. Graduation from a recognised university with not less than 50% of marks in the aggregate; and Higher Diploma in Co-operation (HDC or HDC&BM of the State Co-operative union of Kerala or HDC and HDCM of National Council for Co-operative Training or successful completion of the subordinate (Junior) Personal Co-operative Training Course (Junior). Diploma in Co-operation.

OR

B.Sc (Co-operation with Banking) of Kerala Agricultural University.

3. MBA/CA/CWA/M.Com/M.Sc (Co-operation and Banking) of Kerala Agricultural University will be preferential qualification.

Note:- 1. Separate Ranked Lists will be prepared for General open market candidates (ie.General Category) and employees of Member/Primary Co-operative Societies (ie. Society Category). Candidates will be advised alternatively from the ranked List of general open market candidates and the ranked list of employees of Member/Primary Societies respectively with the first postion going to the general open market candidate. As in the case of all advices of the Kerala Public Service Commission for recruitment against the vacancies of Government Departments, Public Sector Undertakings etc. the rotation will be a continuous one. If there is shortage of candidates in the ranked list of employees of Primary Co-operative Societies, the

vacancies will be filled up from the ranked list of general open market candidates. Such passed over vacancies will not be compensated later. The rules of reservation as laid down in the general Rules 14-17 of the KS & SSR will be followed for appointment from both the lists.

2. The eligible employees of affiliated Member Societies/Primary Co-operative Societies who apply for the above post should obtain the Service Certificate from the Assistant Registrar (General) showing the details of service of the applicant which render them eligible to apply for the post and shall be produced when required by the Commission. The Service Certificate should contain the following details:
