1. Name of Concern : Handicrafts Development Corporation
2. Name of post : Sales Assistant (Special Recruitment from SC/ST)
3. Scale of pay : Rs. 4500-7000/-
4. No. of vacancies : 2 (Two)

Note: The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribe for vacancies reserved exclusively for them will be issued.

5. Method of appointment : Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes only)

Note : Applications received from candidates other than Scheduled Caste/ Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age limit : Should have completed 18 (Eighteen) years and Should not have completed 40 (Forty) years of age as on 01.01.2010. (No other age relaxation will be allowed)

Note : In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications:
 1. Degree from a recognized university.
 2. Ability to speak and write English, Hindi and Malayalam.
 3. 50% of vacancies shall be reserved for female candidates.
 4. Selected candidates will be appointed purely on provisional basis for a period of one year during which period they will be given only a consolidated allowance of Rs.2,000/- per month. On successful completion of one year service, they will be absorbed as Sales Assistant on Rs.4500-7000.

Note:- Selected candidates will be appointed purely on provisional basis for a period of one year terminable without notice at any time during which period they will be paid the scale of pay of Rs.4500-7000 or its revision as applicable from time to time.

8. Method of submitting application :- The applications can be submitted only by On-line facility provided in the website of the Kerala Public Service Commission. Detailed instructions regarding the submission of applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The barcode number in the application form from the Website shall be quoted in all further enquires/correspondence. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.

Candidates should not enclose any documents along with the application, copies of documents to prove educational qualifications, experience, age, community etc. should be produced as and when called for by the Commission.
