Pathanamthitta - 1 (One)

**Note :-** (1) A ranked list will be prepared for Pathanamthitta district in pursuance of this notification. The ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new lists after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier. Candidates from the Ranked List prepared in response to the Notification will be advised for appointment against Head Quarters vacancies also.

(2) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(Ms) No.154/71/PD dated 27.5.1971. A candidate advised for appointment in the Revenue District from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O. (Ms) No.4/61/PD dated 2.1.1961.

Candidates already in Government Service holding the post in any one District are prohibited from applying again for this post, but they can apply to higher posts when notified.

(3) 3% of vacancies shall be reserved for the PH persons to the post vide G.O.(P)No.20/98/P&ARD dated 14.07.1998 as envisaged in section 33 of "Persons with Disabilities (Equal opportunities, protection of Rights and full participation) Act, 1995".

5. Method of appointment : Direct Recruitment
6. Age Limit : Should have completed 18 (Eighteen) years of age and should not have completed 35 (Thirty Five) years of age as on 01.01.2010 with usual relaxation to Scheduled Caste/Scheduled Tribe, Other Backward Communities.

**Note:-** For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (Fifty) years, please see Para (2) of the General Conditions under Part II of this notification.

7. Qualifications: - (1) S.S.L.C. or equivalent and  
(2) Any one of the following qualifications.
  - (a) Draftsman course (Mechanical) Diploma of ITC (MTI) Thrissur.
  - (b) Drawing Group Certificate (KGTE OR MGTE).
  - (c) Second Grade Certificate secured by Draftsman (Civil or Mechanical) Trainees under TT Scheme, College of Engineering or under ITC conducted by the Ministry of Labour, Government of India, after a course of 18 months.
  - (d) A pass in Building Drawing and Estimating (Lower) KGTE/MGTE and any two of the Civil Engineering subjects under KGTE/MGTE.
  - (e) ITI Certificate in Draftsman Trade (Civil or Mechanical) or in Survey trade.
  - (f) Diploma in Agricultural and Rural Engineering awarded by the Kerala Agricultural University.

8. Mode of sending application:

The applications can be submitted by On-line facility provided in the Website of the Kerala Public Service Commission. No application fee is required. The barcode number shall be quoted in all further enquiries/

correspondence. Documents to prove qualifications, age and community have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
