Note:(1) Application should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected his/her name will be removed from the ranked lists and disciplinary action will be taken against him/her. Candidates should note the name of that District against the relevant column in the application. The address to which applications are to be sent is furnished in Column (10) of the notification.

Note.(2)The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G. O. (MS) No.154/71/PD dated 27.5.1971. A candidate advised for appointment in the Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O. (MS) No. 4/61/PD dated 2.1.1961. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

Note:-(3)Separate ranked lists will be prepared for each District in pursuance of this notification. The list of selected candidates published by the Commission in pursuance of this notification shall remain in force for a minimum period of one year from the date on which it is brought into force provided that the list will continue to be in force till the publication of a new Ranked list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies if any, reported during the currency of the lists. 250(two hundred and fifty) candidates will be included in the main list of the Ranked List in each district.

Note: 4 (i) The provisional hands working in the above concern will be given age relaxation to the extent of their Provisional Service put to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of the first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same and when required by the commission. It should also be clearly specified in the certificate that they were not working in the regular service of the concern.

(ii) The Retrenched employees of the Kerala Fisheries Corporation will be given age relaxation as stipulated in the GO(Rt)No.1942/84/PW dated 31/12/1984 to the extent of their service subjected to the condition that the maximum age limit shall not exceed 50 years. These candidates will also be given preference in the matter of the recruitment among other candidates with equal marks. Such candidates should obtain a certificate from the Managing Director, Kerala Fisheries Corporation Limited to prove their length of service in the company and the date of retrenchment and produce the same as and when required by the Commission.

(iii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the service of the Kerala State Civil Supplies Corporation Limited, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that the cancellation of advice for appointment by the commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of his/her probation 240 days from the date of his/her joining duty whichever is earlier.

(iv) Sub paras V,VIII,IX,X,XI and XIII in Para 2 and Para 5,6 and 7 of the General Conditions are not applicable to this post.

5. Method of Appointment : Direct Recruitment

6. Age Limit : Should have completed 18 (Eighteen) years of age and should not have completed 35 (Thirty five) years of age as on 01.01.2010 with usual relaxation to Scheduled Caste/Scheduled Tribe, Other Backward Communities.

7. Qualification : SSLC Pass or equivalent
