- (1) Applications of those candidates who do not belong to Orthopaedically Handicapped category will be summarily rejected. No rejection memo will be issued.
(2) Separate Ranked List will be prepared for Malappuram District in pursuance of this notification. Ranked List, thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above Category of Physically Handicapped unfilled due to the paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (3) Candidates shall submit application for the post to Malappuram District where the vacancy is existing and shall note the name of the district against the relevant column.
(4) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O(MS) No.4/61/PD, dated 2.1.1961. candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to Orthopaedically Handicapped)

6. Age : ISM/IMS:
18-35. Only candidates born between 02.01.1976 and 01.01.1993 (both dates included) are eligible to apply for this post.
Ayurveda Colleges:
19-35 Only candidates born between 02.01.1976 and 01.01.1992 (both dates included) are eligible to apply for this post.

The candidates applying online shall keep the print out (Receipt) of their applications and the barcode number shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age and community etc have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
