- (i) Conventional type applications will be summarily rejected. Candidates shall apply only through online application available with the Kerala Public Service Commission website www.keralapsc.org
 - (ii) Applications submitted by candidates belonging to the Communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
 - (iii) Separate Ranked list will be prepared for above district in pursuance of this notification. Ranked list thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in following district.

- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in GO(Ms) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to Dheevara community only)
6. Age : 19-38; Only candidates born between 2.1.1973 and 1.1.1992 (both dates included) are eligible to apply for the post.

7. Qualifications:

(1) Pass in SSLC or equivalent qualification

(2) Certificate in Ayurveda Nurses Course recognized by the Government of Kerala.

Note:- (i) Appointment of Male and Female candidates shall be made in the ratio 1:5 and in accordance with the rules of reservation and rotation. Separate ranked lists will be prepared for Male and Female candidates.

(ii) Physically handicapped candidates are not eligible to apply for the post.

8. Last date for receipt of applications: 14.12.2011 Wednesday upto 12 midnight

9. Mode of submitting applications:-

Candidates shall submit the application with a Photo uploaded online. Detailed instructions regarding the submission of application are available in the website of Kerala Public Service Commission viz www.keralapsc.org. No application fee is required. The candidates applying on-line shall keep the print out (Receipt) of their applications and the bar code number shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age, community etc. have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.

10. If a Written Test/OMR Test is conducted as part of the selection, admission Tickets of eligible candidates will be made available in the website of Kerala Public Service commission. Candidates are instructed to download their Admission tickets as per the instructions given in the website.

11. At the time of Examination, interview etc. Candidates shall produce their photo affixed ID proof in original(Voters identity Card, Driving License, Passport, Identity Cards issued by Social Welfare Department, Govt of Kerala, to physically Handicapped Candidates, Photo affixed pass book issued by a nationalised bank, PAN card, Identity Cards issued to Government employees by the concerned departments) and its self attested photocopy along with hall Tickets.
