Applications with latest photo uploaded are invited on-line only exclusively from qualified candidates belonging to reservation group of communities of Kerala State (Name of communities and number of vacancies are specifically noted against name of district concerned) on NCA vacancies for selection to the under mentioned post.

1. Department : Technical Education Department
2. Name of post : Tradesman (Electronics)
3. Scale of pay : ₹ 9190-15780
4. Vacancies : Community wise

Note: i) Conventional type applications for the above post will be summarily rejected. Candidates can apply only through the on-line application facility available at the Kerala Public Service Commission website.

ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.

iii) Separate Ranked Lists will be prepared for Kannur and Kasaragod districts in pursuance of this notification. Ranked Lists thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post in the following districts.

- iv) Candidates shall submit application for the post to the concerned District where the vacancy is existing for their respective community and shall note the name of that district against the relevant column. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- v) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS)No.154/71/PD, dated 27.5.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(Ms)No.4/61/PD, dated 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of Appointment : Direct Recruitment
(from candidates belonging to reservation group of communities viz. SIUC Nadar and LC/AI only).

6. Age : 19- 39, only candidates born between 2.1.1972 and 1.1.1992 (both dates included) are eligible to apply for this post. This include the relaxation as per Para 2(i) of General Conditions).

Note:- For conditions regarding other age relaxation please see Para (2) of the General conditions except 2(1).

7. Qualifications:

1. Pass in standard VII
2. JTSLC or ITI or KGTE or KGCE or City and Guilds Examinations in the concerned trade.

1. The certificates awarded by City and Guilds of London Institute after 31-3-1985 will not be accepted.
 2. Candidates should specify the name of the trade/branch also along with the qualification in the application.

8. Mode of sending applications:-

The application with photo uploaded shall be submitted only online. Detailed instructions regarding the submission of the applications are available in the website of the Kerala Public Service Commission viz. www.keralapsc.org No application fee is required. The candidates applying on-line are advised to take a print out (Receipt) of their application and note the barcode number for future reference. The barcode number in the application shall be quoted in all further enquiries/ correspondence. Documents to prove qualification, age, community etc. have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.
