Applications with a latest photo uploaded are invited online only exclusively from qualified candidates belonging to reservation group of communities of Kerala State viz. Hindu Nadar and Muslim for selection to the under mentioned post.

- 1 Department** : Forest
- 2 Name of Post** : Reserve Watcher/Depot Watcher/Survey Lascars/TB Watchers/Bungalow watchers/Depot and watch station watcher/Plantation watchers/Maistries/Timber Supervisors/Tope warden/Thana watcher/Dispensary Attendant etc.
- 3 Scale of Pay** : ₹. 8500-13210/-
- 4 Number of vacancies** : District wise

- NOTE:-** (i) The above mentioned posts are included in the LGS service rules amended as per G.O(P)271/80 dated 3.7.1980. A common ranked list will be prepared for all posts mentioned above in pursuance of this notification. Candidates will be advised from the lists thus prepared as and when vacancies are reported by the appointing authorities. Only one application need be sent for all posts mentioned above noting the name of post applied for as 'Depot Watcher' etc. Separate application need not be sent for each post.
- (ii) Conventional type application for the above post will be summarily rejected. Candidates can apply through online application available at the Kerala Public Service Commission website viz. [www.keralapsc.org](http://www.keralapsc.org).
- (iii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
- (iv) Separate Ranked List will be prepared for above districts in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in following districts.

- (v) The candidates belonging to above reservation communities shall submit application for the post to the district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted

contrary to the above direction and if he/she is selected his/her name will be removed from the ranked list and disciplinary action will be taken against him/her.

- (vi) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G O (MS) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No. 4/61/PD, dated 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified. **Women and PH candidates are not eligible to apply for the post.**

5 Method of appointment : Direct Recruitment (From candidates belonging to above reservation communities only).

6. Age : **For Muslim and Hindu Nadar Candidates :- 18-38 .** Only Muslim and Hindu Nadar candidates born between 02.01.1973 and 01.01.1993 (both dates included) are eligible to apply for the post. (Including the relaxation as per para 2 (i) of General conditions)

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para 2 of General Conditions under Part II of this notification. [except para 2 (i)]

7. Qualifications : -

- (1) Pass in Standard VII(new) or equivalent qualification.
- (2) Physical fitness  
Height -163 cms  
Chest (normal)-79 cms  
Chest (on expansion) -84 cms

Note:- A minimum chest expansion of 5 cms is required

8. Last date of receipt of Applications : 01.02.2012 Wednesday upto 12 Midnight.

9. Mode of submitting application :-

Applications with a photo uploaded shall be submitted online only. Detailed instructions regarding the submission of applications are available on the Website of the Kerala Public Service Commission viz [www.keralapsc.org](http://www.keralapsc.org). No application fee is required. The candidates applying online shall keep the print out (Receipt) of their application and the barcode number shall be quoted in all further enquiries/correspondences. Documents to prove qualifications, age, community etc. have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.

10. If a Written Test /OMR Test is conducted as a part of the selection Admission Tickets of eligible candidates will be made available in the website of Kerala Public Service Commission. Candidates are instructed to download their Admission Tickets as per the instructions given in the website.
