The candidates can avail only one chance either after the publication of the Short List or after the publication of Ranked List.

Candidates desiring to recheck the answer script relating to the written test held for selection to the post may apply for rechecking within 30 days from the date of publication of the Ranked List.

The application for rechecking alongwith original chalan receipt for the prescribed fee for Rs. 10/- under the head of account ``0051-PSC-105 State PSC 99 Examination Fee'' addressed to the District Officer, KPSC District Office, Idukki should reach the office within 30 days from the date of publication of the Ranked List. Application for rechecking received after the stipulated time will not be entertained and the fee once remitted will not be refunded.

Note III : Candidates belonging to SIUC Nadar community included in the Short List and interviewed for the post are treated as belonging to OBC as per judgement of the Hon`ble High Court of Kerala dated 28.08.2000 in O.P. No.7870/88/Y and therefore those included in the Supplementary List for Nadar community are deleted from the list and included in the supplementary list of OBC subject to eligibility.
