**Note III** : Candidates belonging to SIUC Nadar Community included in the Short List and interviewed for the post are treated as belonging to OBC as per Judgement of the Hon'ble High Court of Kerala dated; 28.08.2000 in O.P.No.7870/88/Y and therefore those included in the Supplementary List for Nadar Community are deleted from the list and included in the Supplementary List of OBC subject to eligibility.
