ADDENDUM NOTIFICATION

The Hon'ble High Court of Kerala, vide judgment dated 13.7.06 in WP(C)No.21300/05, had issued directions to enlarge the Ranked List for selection to the post of HSA(English) in several Districts. It is hereby notified that in compliance of the judgment, dated 13.7.06 the Ranked List for selection to the post of HSA (English) in the Education Department in Ernakulam district (Cat.No.3/2003), brought into force w.e.f 17.10.05, is revised as shown below.

The entries in the main list up to and including rank no.59 remain unchanged. Rank Nos.60 to 64 in the main list are cancelled along with all the Supplementary lists except that of Dheevera. The remainder of the main list is rearranged by including the names of the eligible candidates in the order of merit. The candidates interviewed consequent to the High Court judgment are assigned Sl.nos. 201 to 294.
