ADDENDUM NOTIFICATION

The Ranked List for the post of Last Grade Servants (Various Departments) on Rs.2610-3680(PR) (Category No. 56/2006) in Alappuzha District (No. 220/08/DOA) was published on 18.09.08. The List II of the Ranked List consisting of candidates for being filled up against the 3% vacancies earmarked for PH candidates as per G.O(P) NO. 50/07/SWD dated 15.09.2007 was temporarily withheld. The following is the list of candidates who are found eligible to be included in List II on the basis of the Objective Type (OMR Valuation) Test held on 30.06.2007, arranged in the order of Register Numbers and in no way indicates respective rank on the basis of the marks secured in the examination. Alphabet 'A' should be prefixed to the Register Numbers in the list to denote Alappuzha District. Register Numbers of those candidates who are included in the existing Ranked List and those who were found unsuitable in the suitability assessment held on 16.07.2008 and those who were absent for the suitability assessment held on 16.07.2008 have been excluded from this list.

Candidates included in the list will have to produce in person at their own expense the original documents along with self attested copies to prove their claims made in the application, i.e Qualification, Date of birth, Community, Medical Certificate issued by Medical Board Etc. Date time and venue of Suitability assessment will be personally intimated in due course.
